Commercial

Changes effective July 1, 2023 Durable Medical Equipment

- Negative Pressure Wound Therapy in the Outpatient Setting (#42)
 - Clarified policy criteria

Changes effective August 1, 2023 Surgery

- Implantable Cardioverter Defibrillator (#17)
 - Reformatted criteria for clarity
 - Added criteria specific to arrhythmogenic right ventricular cardiomyopathy (ARVC)

Changes effective November 1, 2023 Allied Health

- Enteral and Oral Nutrition Therapy in the Home Setting (#05)
 - New commercial medical policy applies only to Individual members

Genetic Testing

- Identification of Microorganisms Using Nucleic Acid Probes (#85)
 - Updating policy to consider respiratory pathogen panel testing with 12 or more targets to be investigational

Surgery

- Hysterectomy (#218)
 - New commercial medical policy applies only to Individual members and will include pre-authorization requirements for select diagnosis codes

Utilization Management

- Air Ambulance Transport (#13)
 - Updating commercial medical policy to add post-service review for Individual members

Please <u>follow these steps</u> to review the information about your practice every 90 days. Please respond timely to any requests from us for verification of your directory data.

If your clinic or facility submits provider rosters to us, please submit changes, corrections, additions or terminations immediately so we can update our directories as soon as possible. Your roster must be validated and reviewed in its entirety at least once per quarter.
